## **TERMS & CONDITIONS OF THIS STALLION SERVICE APPLICATION**

1. This mare is booked specifically by name. The booking is valid for the mare named and may not be transferred without consent of Westwind Farm Canada Ltd.
2. Mare owner(s) agree(s) that the mare named in this application shall be healthy and in sound breeding condition immediately prior to breeding. Westwind Farm Canada Ltd. reserves the right to reject any mare not in good physical condition, blind, vicious or unmanageable. This mare must be registered with Standardbred Canada and/or the United States Trotting Association.
3. Neither, Westwind Farm Canada Ltd., their owners, members, employees, or agents shall be liable or responsible in any manner for any accident or injury, disease or disability suffered by the mare and/or her foal while at the premises of Westwind Farm Canada Ltd. The mare owner acknowledges that the mare (and foal) shall be on Westwind Farm Canada Ltd. premises entirely at the owner's risk and therefore waives any and all claims resulting from injury or disease.
4. The service fee shall be due and payable when the mare produces a live foal (a foal that can stand up alone and nurse at 24 hours of age) or when the mare changes ownership, whichever occurs first. In the event the mare is sold, the service fee, if unpaid, shall immediately become due and payable and no refund shall be due to any person, under any circumstances.
5. The Federal 6% Goods & Services Tax will be applicable to service fees, boarding and veterinary charges etc., and will be added to all invoices. Westwind Farm Canada Ltd. GST number is 882888100.
6. All fees are payable to Westwind Farm Canada Ltd. All accounts must be settled on receipt of duly rendered statements. A charge of 18% per annum will be charged on all accounts unpaid after 30 days. Westwind Farm Canada Ltd will not issue a mating certificate to mare's owners with an unpaid account.
7. The board rate for mares will be \$18.50 per day. An additional charge of \$4.00 per day will be charged for foals at side. The breeding season will begin February 12, 2010 and end July 6, 2010. Mares must have a negative Coggins Test dated within 12 months of arrival at Westwind Farm Canada Ltd. Westwind Farm Canada Ltd. reserves the right, at its discretion, to retest the mare upon arrival at the owners' expense.
8. Semen transportation is available with prior notification and approval from Westwind Farm Canada Ltd.
9. Westwind Farm Canada Ltd. requires mare owners of all mares to have the mare's vaccinations and de-worming up to date prior to her arrival at Westwind Farm Canada Ltd. A General Health Record along with a copy of Breeding Shed Rules will be returned to you with each approved application. Each must be completed, signed and returned as soon as possible prior to bringing your mare or prior to ordering semen.
